#### III. EXECUTIVE DIRECTOR'S REPORT

Executive Director's Report was delivered by Larry Kay

- A. Welcome Senator Victor Callahan to the Missouri Veterans Commission. Senator Callahan serves as the Minority Floor Leader in the State Senate.
- B. Budget Update Julie Miller gave a report on Governor's Recommendations to the Budget FY 2012. The Commission appears to have funding through FY 2012 without depleting the VCCITF as previously reported at the December meeting due to a \$2 million fund switch from Home Fund to GR and a transfer of \$4.5 million from the VCCITF into the Home Fund. The Commission continues contact with OA-BAP on budget situation.

## IV. PROGRAM REPORTS

Program Reports were delivered (Powerpoint presentation) by Bryan Hunt, Deputy Director

Bryan Hunt gave an explanation of the Heroes Homecoming in the Homes.

Larry Kay reported that the Grants Program is slated to receive the additional \$600,000 in June or July 2010 due to the passage of HB 1893 last year.

Bryan Hunt gave a brief update on the Benefits Task Force and the Outreach Task Force:

Benefits Task Force – Working with the Veterans Organization and the Federal Department of Veterans Affairs to reduce the time for Veteran in filing and receiving VA benefits. They are also working on developing Best Practices Manual.

Outreach Task Force- Planning stage for May Benefits Fair in Columbia.

# V. STAFF REPORTS

Staff Reports were delivered by Tim Norton, Julie Miller, Omar Davis and Melissa Wilding

Tim Norton advised the new Construction Budget request is \$13 million for FY 2012 and FY 2013.

Statewide Audit is complete and should be released in March 2011. MVC will invite State Auditors Office to give presentation at next meeting.

Home Rule Change – discussion held regarding qualifications to reside in a state Veterans Home. MVC will work with Legislature in drafting bill language. A motion was put on the table to approve submittal of statutory change as proposed. Commissioner Pearce made a motion to approve submittal of statutory change as proposed and Commissioner Englund seconded the motion. The motion passed unanimously by a voice vote.

Melissa Wilding is visiting each general assembly members office to distribute the Missouri Benefits and Resource Guide. She also has distributed to Wounded Warriors Transaction Units and other state agencies.

MAVO asked the Commission to avoid increasing cost to Veterans in the Homes Program.

Dewey Riehn gave a brief legislative update to Commissioners.
